Dues will be charged at the current monthly rate listed above, which includes all taxes. There is no lock-in on dues. For all members except Non-Resident, a quarterly food minimum of \$250.00 must be spent. This may be spent in any of our dining areas including the pool and locker room. The amount credited is exclusive of service charge and tax. It can be applied only to food purchases.

All Golfing memberships, except Non-Resident, will be charged for Club Storage, \$121.90, billed in December, yearly Handicap Fees, \$35.00 each member, and a yearly Range Fee, \$174.90, 1/3 billed April, May, June. Full Lockers (\$180.20/year), Half Lockers (\$90.10/year) billed in April, available for men and women.

All memberships, except Non-Resident, include a membership to Nautilus Fitness Club. Initiation fee is waived with two-year agreement (Military/Law Enforcement waived with one-year agreement). 1. I promise and agree to return any cart that I may rent and/or use from time to time immediately following my round of golf or other activity in as good condition as I received it (normal wear being excepted).
2. I promise and agree to pay any damages that are sustained to any cart while in my care custody and control. I also agree to be personally responsible for any bodily injury, and/or property damage incurred by reason of my use of the cart.
3. I promise and further agree to hold BHCC and the owner of the cart free and harmless from any damage (bodily injury or property damage) or claims of any nature whatsoever that may arise from or through my use of any golf cart on the premises of BHCC, except as a result of mechanical failure or defects.
4. I represent that I am familiar with the operation and use of the electric carts and that I have read the instructions appearing on the cart and that I am physically able and willing to operate and control the cart in a prudent manner and in accordance with said instructions.
5. I understand that the management or staff of BHCC has the right to withhold my privilege to operate or ride in a golf cart if in the management or staff's opinion I am not physically or mentally able to do so.
